

PERFORMANCE BASED CONTRACT GUIDELINES

1. WHAT IS THE PURPOSE OF THE SERVICE?

Dr. Andrew P. Levin will provide forensic psychiatric examinations - pursuant to §913 of the New York State Education Law - and provide testimony at administrative hearings on an as needed basis.

2. AMOUNT OF SERVICE

Dr. Levin's fee(s) shall not exceed \$15,000.00.

3. WHO IS SERVED?

Education Law section § 913 authorizes a board of education to have a medical examination of an employee conducted when questions arise as to the employee's physical or mental health.

4. WHO WILL PROVIDE SERVICES?

Dr. Andrew P. Levin.

5. WHAT WILL BE COMMUNICATED TO DISTRICT PERSONNEL, PARENTS, OTHERS ABOUT PROGRESS AND RESULTS OF THE SERVICES?

Dr. Andrew P. Levin will submit his evaluation/ report directly to Human Resources.

The quality of the evaluations, examination reports and testimony will be judged by Human Resources, the Superintendent and the Corporation Counsel's Office.
