Via Resolution 17.6 at their stated meeting on March 16, 2016 the Board of Trustees awarded a requirements contract # 619430 to LIRO Engineers, Inc. for an amount not to exceed \$1 million. This resolution is to assign the following specific capital work under that contract.

SCOPE OF WORK

An RFP for this task was issued on April 6, 2017 to the 4 firms who were awarded requirements contracts via the above resolution.

Rationale: Responses were received on April 19, 2017. As result of the examination of the responses and interviews with respondents it was determined that LIRO Engineering, Inc. would be the best firm suited for this project.
E&R Engineering was the only other proposer at \$30,750.00.

This project is to be authorized for \$250,000.00. The scope of work is to include but is not necessarily limited to: abatement of asbestos containing material in yet another crawl space and remediation of all materials listed in the Asbestos Management Plan in the 2016 AHERA Triennial Inspection report.


