This is to continue to provide for service and repair of the HVAC controls and pneumatic compressors throughout the district. This includes thermostats, valves, dampers and other devices controlling HVAC as well as the air-compressors supplying the air to run these controls.

Rationale: In compliance with General Municipal Law 103, this contract was publicly advertised in August 2017. Bids were opened and read aloud in public on September 9, 2017. Only one bid was received which was from EMF who has won all bids for this work since 2011. This contracts is renewable annually under mutual agreement for up to additional 2 years. All terms and condition remain the same except that changes in NYS Prevailing wages will be reflected.
