This is to amend the above agreement awarded to Fuller & D' Angelo Via Board Resolution Item 17.5 on January 20, 2016. That resolution provided up to \$1 million for A/E work over three years, ending

January 17, 2019.

To date F&D has been engaged on 6 projects under this agreement with fees totaling \$814,861.80. A seventh project; CIP 10825 at School 17 with a fee of \$295,000 for a term of 2 years, to January 2021 is being presented under a separate resolution . This will exceed the existing \$1 million limit and terminus date of January 17,

Therefore , this amendment is necessary to fund the above and other potential assignments for F&D.

The \$1.5 million dollar figure indicated above is an upper limit for expenditure under this agreement and will not be encumbered unless

specific tasks are assigned, via Board resolutions.
