

## **PERFORMANCE BASED CONTRACT GUIDELINES**

### **1. WHAT IS THE PURPOSE OF THE SERVICE?**

Youth Theatre Interactions, Inc will provide performing arts instruction to specific populations of Yonkers Public School students based on the administration's choice.

- YTI will provide performing arts instruction to the students of Scholastic Academy, Charles E. Gorton High School, Robert C. Dodson Middle School, and Cesar E. Chavez School. The purpose of this instruction is to provide a continuity of services throughout the end of the school year so that the following objectives can continue to be met: expose children to the arts, provide an outlet for creativity, engage students in an activity that will increase their overall wellness and physical activity level.

Youth Theatre Interactions, Inc will also provide performing arts instruction to students at 92 Main Street. The purpose of this instruction is to provide a continuity of services throughout the end of the school year so that the following objectives can continue to be met: expose children to the arts, provide an outlet for creativity, engage students in an activity that will increase their overall wellness and physical activity level. This will also link the school and community.

### **2. AMOUNT OF SERVICE**

- YTI will provide performing arts instruction to students at
  - Scholastic Academy (15 sessions)
  - Charles E. Gorton High School (50 Sessions)
  - Robert C. Dodson School (33 Sessions)
  - Cesar E. Chavez School (33 Sessions) and
  - At YTI studio for students from the abovementioned schools and classes for schools under the 1003a grant
- Each session will be a maximum of one hour.
- Payment will be made within 90 days after receipt by the school district of an approved invoice for services rendered.

### **3. WHO IS SERVED?**

Performing arts instruction will be provided directly to students at the above named school.

### **4. WHO WILL PROVIDE SERVICES?**

Youth Theatre Interactions, Inc. and its employees will provide all services. Ricardo Lima, the Executive Director of Youth Theatre Interactions, Inc. will oversee all programs.

### **5. WHAT WILL BE COMMUNICATED TO DISTRICT PERSONNEL, PARENTS, OTHERS ABOUT PROGRESS AND RESULTS OF THE SERVICES?**

Progress and results of the program will be communicated through a final report which will be submitted to the district. Additionally, final performances will be attended by district personnel to judge the progress and results of the program.

### **6. HOW WILL THE QUALITY BE JUDGED?**

The Yonkers Public Schools will conduct ongoing monitoring of the quality of the contractual services provided by the contractor. Such monitoring will include but is not limited to agendas, site visits, summary reports, surveys, and attendance at performances. The Yonkers Public

Schools will use a standardized evaluation for all training sessions delivered. The district will share the results of the evaluations with the vendor for feedback and to plan for future training.
