RE: **Request for Emergency Declaration**
Gas Service Line Repairs at Museum School 25

I have approved the attached Request for Emergency Declaration from Executive Director John Carr. On Friday, April 5th, Con Edison was dispatched by the School Facilities Department and cleared the building. Con Edison notified the District that they found multiple leaks on the service connection and meter rig and directed the District to shut the gas at the street and have the leaks repaired by a gas-certified plumber.

The heat plant is a new dual fuel system so heat to the building is currently provided by the heating fuel oil. However, the only source of hot water is from natural gas. This is a Westchester County Department of Health violation that must be addressed immediately. Therefore, this is a request for an emergency declaration to cover the immediate repairs.

Sundance Energy Contractors, Inc. is being engaged to do this work. The costs are difficult to determine without knowing the precise source of work. At this time, the estimated cost range is from \$10,000 to \$55,000. The work is expected to be completed the week of April 8th.


