This Project was authorized under Resolution Agenda Item #14.2 at the Board of Education Meeting of March 19, 2013 for the amount of \$1,150,000 and being re-authrized under a separate resolution at the Board of Education Meeting on April 17, 2013 to the amount \$1,300,000. The restoration work for VIVE School Yonkers Pathway to Success (VIVE) is to address the 2010 Building Condition Survey Health and Safety issues which will include but not be limited to HVAC, HVAC controls, security, communication and clock systems. Other work is to include replacement of select exterior doors, upgrading exterior lighting and mitigating below grade ground water infiltration.

The Department recommends that KG&D Architects, PC, (KG&D) be selected for this work as they performed acceptably on previous capital improvement projects of the same size and scope. The services that KG&D will provide include but are not limited to; Review existing drawings and survey the school infrastructure and to confirm **Rationale:** existing conditions, confirm the scope of work and develop a project budget, prepare construction documents and specifications for procurement of a Building Permit from the NY State Education Department, issuance of construction documents for public bid and provide the District with construction administration services.

> FOCUS POPULATION: The stakeholders of the VIVE School. ASSESSMENT PROCESS: The School Facilities Management Department will be working closely with KG&D to monitor progress and content.

CONTRACT DURATION: April 18, 2013 through December 31, 2014. It is anticipated that the construction for this project will occur during the summer of 2014 and close-out documents and Final Payments to be on or about the December 31, 2014.
