 22.25 Award of CAPITAL Fund Construction Contract for Bid No. 6133 GC ROOF & MASONRY CONTRACT 1 OF 5, CIP10656 "Reconstruction of Portions of the Exterior Envelope, Select Interior Finishes and HVAC Systems" at Gorton High School to Hull Construction & Restoration, Inc., in an amount not to exceed \$1,998,000.00 for a term of 365 calendar days.

District Goals:

This resolution is to grant the administration the authority to enter into contract as described above. In compliance with General Municipal Law 103, this contract was let for public bid on April 14, 2017. Bids were opened in public and read aloud on May 12, 2017. Bids were examined and all due diligence observed in determining the lowest responsive and responsible bidder.

Since this is a Wick's Law project, 5 separate bids were let: 1. GC Roofing & Masonry, 2. GC Interiors & Site Work, 3. HVAC, 4. Plumbing and 5. Electrical. Bid results for Contract 2. GC Interiors & Site Work were rejected because there was only one bidder and they were about \$1 million over the engineer's estimate. Since the work entailed in Contracts 3, 4 and 5 is dependent on the work in Contract 2 none of them could be awarded either. This portion of the project will be rebid in the fall for a spring 2018 construction.

The overall scope of construction work anticipated for this CIP at Gorton includes but is not be limited to the reconstruction of: main shingle roof, auditorium envelope, exterior doors, restoration of the main gym floor & doors, various hallway ceilings, ADA compliance and the reconfiguration of three basement classrooms for light, safety and ventilation. The overall project cost is anticipated to be \$5.5 to \$6.0 million.

The work was designed by Fuller & D'Angelo, P.C., Architects (F&D). The engineer's estimate for the GC Roof & Masonry work is \$2.3 million. A total of three (3) bids were received. The first apparent low bidder was rejected because of discrepencies found on the vendor background questionnaire.

After interviewing Hull and in confirming the Contractor understood the scope of work F&D and the department recommend that the District make this award.

The scope of work for Contract 1 of 5 GC Roofing & Masonry includes but is not limited to: replacement of the flat roofs over the auditorium, replacement of the pitched shingled roofs over the main building, masonry façade restoration at the auditorium court yards, chimney restoration and related asbestos abatement.
