## PERFORMANCE BASED CONTRACT GUIDELINES

## 1. WHAT IS THE PURPOSE OF THE SERVICE?

The purpose of the artist residency program is to provide an arts experience that will enhance social, personal, artistic and academic goals for elementary school students while providing professional development for teachers through hands-on experience and observation of artist work in the classroom. Students will learn artistic techniques such as dance, painting, theater arts, music and ceramics that strengthen life skills, build self-confidence, self-esteem and positive peer relations.

ArtsWestchester will administer visual, literary and performing art residencies for 4<sup>th</sup> and 5<sup>th</sup> grades students in School 17 and 4<sup>th</sup>, 5<sup>th</sup>, 6<sup>th</sup> grades in William Boyce Thompson School in Yonkers, NY.

In School 17, from September through December 2019, each artists' services will include a planning session with the school administration, 35 hands-on, art-making sessions, a culminating event. From January through June 2020, each artists' services will include a planning session with the school administration, 58 hands-on, art-making sessions, a culminating event. For each residency the amount allocated for art supplies and the procurement of it will be determined by the teaching artist and school administration.

In William Boyce Thompson, September through December 2019, each artists' services will include a planning session with the school administration, 22 hands-on, art-making sessions, a culminating event. From January through June 2020, each artists' services will include a planning session with the school administration, 35 hands-on, art-making sessions, a culminating event. For each residency the amount allocated for art supplies and the procurement of it will be determined by the teaching artist and school administration.

### 2. AMOUNT OF SERVICE

In total, afterschool, ArtsWestchester will provide 8 planning sessions with artists, teachers and administration, 300 hands-on artist workshops with students and staff and 8 culminating sessions for students, parents and administration from September 2019 through June 2020 for the 4<sup>th</sup> and 5<sup>th</sup> grade students in School 17 and 4<sup>th</sup>, 5<sup>th</sup> and 6<sup>th</sup> grade students in William Boyce Thompson.

There will be 4 artists contracted to serve School 17 in total: two in the fall (September through December 2019) and two in winter/spring (January through June 2020). The artists in the fall will be contracted for one planning session, 35 art-making sessions and one culminating event. The artists in the winter/spring will be contracted for one planning session, 58 art-making sessions and one culminating event. These services are to take place on Tuesdays, Wednesdays and Thursdays from 2:45-3:30 p.m. Dates will be mutually decided between the ArtsWestchester teaching artist

and school administration. <u>Each artist will be selected by School 17 and be designated for a particular day of the week.</u>

There will be 4 artists contracted to serve William Boyce Thompson in total: two in the fall (September through December 2019) and two in winter/spring (January through June 2020). The artists in the fall will be contracted for one planning session, 22 art-making sessions and one culminating event. The artists in the winter/spring will be contracted for one planning session, 35 art-making sessions and one culminating event. These services are to take place on Mondays and Wednesdays from 2:45-3:30 p.m. Dates will be mutually decided between the ArtsWestchester teaching artist and school administration. Each artist will be selected by William Boyce Thompson and be designated for a particular day of the week.

#### 3. WHO IS SERVED?

ArtsWestchester will serve the 4<sup>th</sup>, 5<sup>th</sup>, and 6<sup>th</sup> grade students at Boyce Thompson grade students and 4<sup>th</sup> and 5<sup>th</sup> grade students at School 17 through hands-on visual, performing and literary artist residencies held afterschool.

#### 4. WHO WILL PROVIDE SERVICES?

ArtsWestchester maintains a roster of over 70 teaching artists who are professional visual, performing and literary artists. Each artist undergoes a rigorous application and interview process to ensure that they are current in their respective field, have experience working with various populations and understand how to conduct an art residency using the arts to build social and academic goals. A list of teaching artists will work with students at School 17 and William Boyce Thompson for the services set forth above.

## 5. WHAT WILL BE COMMUNICATED TO DISTRICT PERSONNEL, PARENTS, OTHERS ABOUT PROGRESS AND RESULTS OF THE SERVICES?

Each residency will begin with a planning session which outlines the goals of the workshops. A planning form is agreed on by both the school teachers and artists is completed.

Planning and final summary forms are completed by the school teachers and teaching artists. See attached. The focus of art residencies is on artistic, social, personal and academic goals.
