Proposal for Architectural and Engineering Services for Fire Code Compliance at PS-14, Yonkers, NY.

PROJECT UNDERSTANDING

Greenman-Pedersen, Inc. (GPI) and its sub-GPI Team, Michael Shilale Architects (MSA), have reviewed the identified scope of the work of Fire Code Compliance at Public School 14. After careful evaluation of the project scope, and observation of the existing conditions, GPI has prepared this proposal response with any and all associated fees and reimbursables, to provide Architectural and Engineering Professional Services for the subject Yonkers Public School building restorations work.

Greenman-Pedersen, Inc. (GPI) and its sub-consultant, Michael Shilale Architects (MSA) shall perform the normal architectural and engineering services as deemed necessary to insure a complete biddable and permitted design. All design shall be in accordance with all Federal, State (State Education Department, S.E.D.), County and local codes and regulations. GPI and MSA will complete, submit, and follow to approval all forms and paper processes required by the New York State Education Department from the LOI to project closeout including all Change Orders and Certificates of Substantial Completion (CSC).

Greenman-Pedersen, Inc. (GPI) and Michael Shilale Architects (MSA), will perform the full scope of services as outlined in RFP#420-19-20.

PROJECT SCOPE OF WORK AS PER RFP 420-19-20

- 1. Replacement of entire exterior Fire Escape Stair Tower, including a full code compliance evaluation.
- 2. Masonry repairs to affected exterior brick areas.
- 3. Installation of one pair of exterior doors at Gym (North wall, near kitchen), including necessary wall, and frame and flooring modifications as part of the new installation.
- 4. Installation of new exterior ADA compliant existing ramp from new Gym doors to the Winfred Avenue side of the school, to include required hand rails etc.

Note: Minor additions and deletions to this scope of work could be expected as the detailed design progresses or based on changes in field conditions and / or owner input.

PROJECT BUDGET ADEQUACY

GPI and MSA believe that the total budget of \$800,000 (including soft costs) is adequate for the scope of work described in the RFP.

Also, GPI and MSA believe that only an ACM sub-consultant is required, at the estimated cost shown in the fee breakdown.

ASSUMPTIONS, LIMITATIONS AND EXCLUSIONS

- GPI and MSA are not responsible for typical or extended review durations at NYSED and the duration listed in the fee breakdown is solely on an assumption based on prior NYSED submissions. GPI and MSA shall not be held responsible for any milestones or bidding deadlines extended or missed due to NYSED review durations.
- The milestone duration stated in the fee breakdown assume that GPI / MSA continue to move forward with design while YPS performs a design review. GPI / MSA expect to receive YPS design review comments within (5) business days of each submission.
- Scope of work which is increased / decreased due to construction budgets or YPS criteria changes etc and could
 inherently impact the submission schedule, shall be discussed with YPS prior to inclusion into the design
 documents and an agreement shall be made as to how this will impact and extend the submission deadlines.
- YPS will provide GPI / MSA will all existing building design drawings and surveys etc. prior to NTP of kickoff. If
 required as part of the design documents, a separate fee will be provided to YPS for a NYS licensed topographic
 survey to be performed. If existing building design drawings are not available, GPI / MSA will revise the fee and
 associated submission dates stated in the fee breakdown to accommodate for this extended scope of work and
 any schedule extensions.
