

THE SCAFFOLDING SHALL BE BARICADED FROM SCHOOL OCCUPANTS WITH MINIM 8’ HIGH x ¾” THICK PLYWOOD SHEETHING HAVING ALL EXPOSED SURFACES AND CONERS SAFETY PADDED. SCAFFOLDING SHALL ALSO BE SAFELY ANCHORED AND SECURED TO THE BUILDING STRUCTURE WHEN NOT IN USE BY THE CONTRACTOR. LOCATION AND ORIENTATION OF SCAFFOLDING TO BE COORDINATED WITH YPS REPRESENTATIVE.”


