Procurement via GML104b N.Y.S. Contract PT63104, Award #20191, Group 77201, expiration date August 26, 2020.

This is to continue with Simplex by a new award under NYSOGS contract. It is in lieu of an extension to provide all services for the testing, service and maintenance of all Fire Alarm Systems in the Yonkers Public School District. All terms, conditions and prices remain the same as last year.

Rationale:

The district is taking advantage of the NYSOGS contract with SimplexGrinnell, LP by re-engaging them for the 2018-19 year. They have worked on for the District in the past having been awarded and completing several contracts both by competitive bidding and through NYSOGS.

As mandated in the Fire Code of New York State No. 906.2 General Requirements, Fire extinguishers shall be selected, installed and maintained in accordance with this section and NFPA 10. Additional requirements by the New York State Education Department Commissioner Regulations Part 155.8 - Fire and Building Safety Inspections: All fire extinguishers operated by a public school district or board of cooperative education services shall be inspected for number, quality, tested and certified at least once annually, or at any other time deemed necessary by the Commissioner.
