Rationale: This to award the "Repair Clocks, Intercoms, and PA systems" to Symbrant Technologies for the amount \$123,725.00 for a term of 356 calendar days.

Bids for RFB6706 were publically advertised, received and opened on November 12, 2021.

Only one bid was received and reviewed. This year's award is \$34,725.00 more than last year's contract due to increased quantities in the bid documents.

Symbrant Technologies was the sole bidder, however they have won this contract in the past through competitive bidding and have performed acceptably. This latest bid although higher, is in line with the total amount spend on this work in the past. Last year's contract was awarded for \$89,000.00. The amount including a change order of \$25,278.00 will be expensed by the contract end date of January 2022.

This contract has a term of one year, renewable under the same terms and conditions by the mutual consent of both parties for up to four additional years for the repair and replacement of School intercom & public address systems, and clock systems.




