Via Resolution 17.5 at their stated meeting on January 20, 2016 the Board of Trustees awarded a requirements contract to KG&D Architects and four other shortlisted firms for an amount not to exceed \$1 million per firm. RFP 420-17-01 was issued to these five firms and upon examination KG&D has been determined to be the best fit for this particular project.

This resolution is to assign the task of providing professional architectural and engineering study, survey and design for the Smart School Bond Act applications further described below:

Rationale: 1.01 Kahlil Gibran School 28: Estimated Project Cost: \$16 million. Expandable 12 classroom addition, demolition of modular classrooms, related building improvement and site work. At this time, it is proposed that the new addition be two story (modular construction) building of approximately 22,000 s.f. of floor space, connected to the main building, elevator, in class lavatories, common fire alarms & public address systems, separate heating and air-conditioning plants, and site upgrades.

1.02 Eugenia Maria DeHostos School: Estimated Project Cost: \$3 million. Reconfiguration of existing spaces to provide 4 (net) additional Pre-K, General and Utility Classrooms. This includes repurposing/reconfiguring unused basement level space, existing classrooms, library and multipurpose rooms. Current project cost is estimated to be roughly \$3 million.






