Engagement Fees

In light of the current financial difficulties of the Yonkers Public Schools and the City of Yonkers as revealed in the Mayor's Executive Budget proposal released April 13, 2018, we want to provide some financial relief.

Accordingly, as a result of steady improvement for the past several years made by finance department personnel and the added efficiencies that results during the audit process, we are revising our proposed fee estimate to include the Contract for Excellence agreed upon procedure at no additional cost. This will save the Yonkers Public Schools \$125,000 over the duration of this agreement.
