Via Resolution 17.5 at their stated meeting on January 20, 2016 the Board of Trustees awarded a requirements contract to Greenman – Pedersen, Inc. (GPI) for an amount not to exceed \$1 million. This resolution is to assign the following specific capital work under that contract.

GPI will be required to produce the design plans, specifications, estimates, SED building permits, bid documents and low bidder recommendations and basic construction administration for the above referenced project.

## Rationale:

The scope of construction work anticipated will include but not be limited to the replacement of ceilings, lights and pipe insulation and related asbestos abatement in the school's Autoshop Wing; replacement of the fuel oil tank and perform a gas feasibility study for converting the school to dual fuel capability.

The overall project cost is anticipated to be \$1.75 million, however only the cost of this particular task (\$90,000.00) has been authorized as of this date. A more precise scope and construction cost estimate will be defined under the Schematic Design portion of this design work.

Construction is anticipated to commence in the summer of 2016 and be completed by September 2017. This task order is to end by December 31, 2017.
