**Subject:** 17.7 AWARD OF A GENERAL FUND ANNUAL SERVICE CONTRACT for Truck Repairs to Argyle Motor Works, dba H&C Truck Repair, Yonkers NY, \$90,000.00. Term is for one year ending October 31, 2016. This is \$10,000 less than in cost than in previous years.

**Rationale:** This bid was opened on Sept. 9, 2015 and H&C was the sole bidder. After performing its due diligence and based on positive past experience with H&C Truck Repair the department recommends the award of this contract. This is a time and material basis bid. The original bid is based upon using canvassing quantities of hours and materials estimated based upon much higher rates of pay and came in at \$71,580.00. However, the YPS Facilities Maintenance Department estimates \$90,000.00 will be needed for truck service repairs and parts over a 12-month period. The Department recommends the contract be awarded to the responsive bidder, Argyle Motors dba H&C Truck Repair in the amount not to exceed \$90,000.00 for time and materials over a 12-month period.

AND BE IT FURTHER RESOLVED: That the Yonkers Board of Education authorizes the Superintendent of Schools to enter into a contract with this vendor.




