**Rationale:** Policy proposals were solicited by the District's broker Nausch, Hogan and Murray. Greenwich Insurance Company provided the most advantageous proposal at 18.67% reduction from the expiring policy. 14 other companies were approach and AIG, Western World, Ironshore, QBE submittin the quotes which were in excess of Greenwich Insurance Co. Other companies decline to offer a proposal due to requested limits, or not being in the market for the coverage.






