Via Resolution 16.11 at their stated meeting on March 22, 2018 the Board of Trustees awarded the above subject assignment to KG+D in the amount of \$30,000.00. Unfortunately the work required for the handling of asbestos containing building materials (ACBM) was inadvertently omitted from that task and has to be included under this amendment. The upset cost for his work is anticipated to be up to \$10,000 for sampling, testing and the design for the amelioration of ACBM issue, if any. This is a direct reimbursement for services by others with no mark-up.

The scope of work for CIP10824 includes but is not necessarily limited to the roof, masonry façade, interior finishes and related asbestos abatement in the vicinity of Stairwell "A" at the north west corner of the building. Project cost is estimated to be \$230,000 to \$250,000. Construction is anticipated to take place in late summer or fall of 2018.
