At the time that this letter was composed, those providers and the specific examinations that have been approved for use as a 4+1 Pathways examination are:

*\*These examinations are only available annually in the month of June. There are no August or January administrations of these Checkpoint B examinations.*

As a result, Oneida-Herkimer-Madison BOCES is currently the sole source vendor for Checkpoint B examinations in French, Italian, and Spanish that are administered in the month of January. Oneida-Herkimer-Madison BOCES is also a sole source vendor for Checkpoint B examinations in American Sign Language that are administered in June.
