

PERFORMANCE BASED CONTRACT GUIDELINES

1. WHAT IS THE PURPOSE OF THE SERVICE?

The purpose of this service is to provide a high quality six week summer day program for children in temporary housing. Children will be provided breakfast, lunch and a snack daily. Students will attend weekly trips and instructional and recreational swim at the YMCA and will be provided with a camp T-shirt. All materials purchased will pertain to the day to day activities the children will partake in with our specialists in sports, art, performing arts, literacy, conflict resolution and computer programs similar to iReady and/or Dreamworks.

2. AMOUNT OF SERVICE

The camp will operate for six weeks beginning early July and ending mid-August, Monday through Friday from 8:30am to 3:00pm. Summer Day Camp tuition with transportation: \$750; without transportation: \$550. The camp will operate out of a Yonkers Public Schools facility (location pending).

3. WHO IS SERVED?

This contract will serve Yonkers Public School students from families who are homeless or living in transitional housing.

4. WHO WILL PROVIDE SERVICES?

Congregations Linked in Urban Strategy to Effect Renewal, Inc.

Congregations Linked in Urban Strategy to Effect Renewal Inc. Director of Youth and Family Programs will report regularly on the progress of registration, attendance, and the ongoing activities of the program participants.

6. HOW WILL THE QUALITY BE JUDGED?

Children and parents complete evaluation forms at the end of the program. The Administration of Congregations Linked in Urban Strategy to Effect Renewal Inc. evaluates the quality of the program by reviewing attendance records, evaluating staff performance, review of camp activities and the feedback collected from parents, children and staff.
