PERFORMANCE BASED CONTRACT GUIDELINES

1. WHAT IS THE PURPOSE OF THE SERVICE?

Harambee Dance Company outreach program is committed to providing cultural stimulation and enrichment through quality dance and music instruction. Our classes are designed to tap into the creative and artistic potential of each student and provide them with long-lasting experiences that will add them and becoming responsible and productive members of the Community. Classes will focus on technique, education, creativity, and building relationships. A presentation at the end of classes will demonstrate an accumulation of what students have learned.

2. AMOUNT OF SERVICE

The cost of dance and music instruction is 15,000. This includes dance and music classes during the week and Saturday program classes.

Dance and music instruction will be provided to students as determined by school personnel.

Harambee classes are taught by professional artist of the dance company with many years of teaching and performance experience. Each teaching artist receives training in Harambee teaching philosophy and curriculum which is adapted to meet the needs of the school and students.

Harambee staff will attend school partner meetings and report progress/obstacles to Administration. Harambee Dance Company executive director/artistic director maintains ongoing communication with teaching artists and school personnel through site visits and reports to ensure that instruction is being provided at the highest level possible. In addition, school personnel and parents are invited to the end of the session sharing to observe the progress of the students.

The dance company provides a curriculum which is designed to provide high-quality learning experiences for all students. Classes will be evaluated based on teaching artist ability to engage students in the curriculum, students progress and participation.
