This amendment will increase their assignment from \$536,200.00 to \$637,700.

Via Resolution 17.5 at their stated meeting on January 20, 2016 the Board of Trustees awarded a requirements contract to Greenman-Pedersen, Inc. (GPI), for an amount not to exceed \$1 million. Via Resolution 22.22 at the June 2017 stated meeting this contract was amended to increase the upset funding limit to \$1.5 million and extend the term for another 3 years.

This project has grown from a site study regarding parking to a two<br/>phase comprehensive rebuild of the existing building, demolition ofRationale:the modular buildings, roughly 85 new parking spaces and a new 6<br/>classroom addition under the Smart Schools Bond Act. The latest<br/>iteration of the scope has been expanded to now include upgrades<br/>and ADA accessibility to select restrooms, provisions for air-<br/>conditioning, new PA system, creation of a new science classroom<br/>and Hi Tech security. The project budget is now \$12 million.

The project has been separated into two phases. Phase 1 includes the rebuilding of the existing building and the parking improvements, roughly \$5.5 million. Phase 2 includes the demolition of the modular and the construction of the new 6 classroom addition at roughly \$6.5 million. The overall project cost is estimated to be \$12 million. Construction is for Phase 1 is targeted for 2019 and Phase 2, 2020.
